3. Discussion of document outlining the process for responding to CoC violations at MGM 2024

A workgroup composed of 3 BoD members and representatives from CODIE and the Maize Meeting Steering Committee worked on revision of the document outlining the process for reporting Code of Conduct violations, and the process to be followed when such reports are received. Revisions were made in light of recommendations of the Inclusive Conference Workgroup of the NSF Roots and Shoots project, our past experience, and to clarify the role of the professional ombudsperson we will have at the 2024 conference. The document was thoroughly discussed and some additional revisions and clarifications were made accordingly. Upon approval by the BoD, this document will be posted on the MGC conference website.

Motion made and seconded to approve the document as it now stands (for 2024). Unanimously approved (9 votes in favor).

Motion made and seconded to appoint three BoD members to the subcommittee referred to in this document who will have the job of investigating and responding to CoC violations. Motion passed with 8 votes (unanimous).
